3. Special Guest

Vice-President Undergraduate calls on Special Guest Professor Clare Pollock, Senior Deputy Vice-Chancellor and Provost to address the SRC on Australian Universities Accord Discussion Paper.

Senior Deputy Vice-Chancellor and Provost, apologises for not attending the SRC General Meeting in person at Hawkesbury, acknowledges the Traditional Custodians of the land in which the Senior Deputy Vice-Chancellor and Provost meets and pays respects to the Elders' past, present and emerging, extending that respect to all Aboriginal and Torres Strait Islander people in attendance.

Senior Deputy Vice-Chancellor and Provost introduces to the Australian Universities Accord as a national scale initiative inviting the attendees to provide input and ask questions on the subject.

Senior Deputy Vice-Chancellor and Provost states that Federal Education Minister Jason Clare initiated a review on higher education creating the Australian Universities Accord and appointing Vice-Chancellor of Western Sydney University Barney Glover as a review panel member.

Senior Deputy Vice-Chancellor and Provost seeks input from within the university due to the involvement of Vice-Chancellor of Western Sydney University Barney Glover.

Senior Deputy Vice-Chancellor and Provost shares and presents three-slides on the Australian Universities Accord and offers to send the presentation to the SRC to distribute.

Senior Deputy Vice-Chancellor and Provost asks for feedback from the students attending the SRC General Meeting.

Vice-President Undergraduate thanks Senior Deputy Vice-Chancellor and Provost, expressing support for the Australian Universities Accord highlighting the no-caps for indigenous students and further support for asylum seekers.

Vice-President Undergraduate calls on any requests to discuss the initiative with Senior Deputy Vice-Chancellor and Provost, Professor Clare Pollock.

Campbelltown Campus Representative, Robert Reed, notes the equity and diversity noted in the Australian Universities Accord and questions what focus has been placed on disability and carers within the Australian Universities Accord.

Senior Deputy Vice-Chancellor and Provost addresses the question stating that the equity described in the Australian Universities Accord is across all underrepresented groups.

Senior Deputy Vice-Chancellor and Provost makes note of the 2008 education review and its determination of a forty percent undergraduate requirement, that has recently exceeded except within regional and rural areas.

Senior Deputy Vice-Chancellor and Provost states that these are underrepresented groups along with Indigenous and disability as the equity described in the Australian Universities Accord is inclusive of all groups.

Women's Representative, Sandy Lindsay, seeks clarification on the data gathering methods for the Australian Universities Accord, questioning if other methods have been utilised or only email submissions as specified and noting an example for such alternative methods is the Western Success team.

Senior Deputy Vice-Chancellor and Provost lists the various groups with which input has been sought from. These being research committees, education committees, academic senate, SRC, participation and student support programs such as Western Success led by Angelo Curtis who provided data from those groups.

Senior Deputy Vice-Chancellor and Provost continues to say that low SES (socio-economic status) groups, regional groups and indigenous groups are most represented at Western Sydney University and highlights this importance.

Women's Representative comments on students who have fallen victims to the jobs ready graduate programs noting that many don't know the program exists until they fall victim to it.

Women's Representative expresses their support that Western Sydney University is aiming to adjusting those barriers.

Senior Deputy Vice-Chancellor and Provost empathises with the challenges that students are facing, stating that sometimes only when a barrier is hit is it then realised that the barrier is there.

Senior Deputy Vice-Chancellor and Provost states that it's Western Sydney University's responsibility to remove the barrier or intervene before the barrier takes effect.

Senior Deputy Vice-Chancellor and Provost expresses the notable hardships of first year students and supporting students through their studies, not penalising students for their hardships.

Vice-President Undergraduate thanks pollock for the work being completed at Western Sydney University for the students and great communities.

Senior Deputy Vice-Chancellor and Provost notes how fantastic welcome week day one at Parramatta South was and wishes that studies go well for those attending.


Bankstown Campus Representative withdraws motion 12.1 noting that this request was made to Bowen Fucile, General Secretary prior to the meeting and was not followed.

Vice-President Activities speaks to Item 12.4, expressing that the jackets act as self advertisement of members within the Student Representative Council enabling students to identify who their representatives are in an effort to increase engagement with their representatives.

Online Campus Representative speaks to Item 12.4, expressing their support for the motion as it provides students the ability to find and access their representatives and the support associated.

Women’s Representative expresses concerns with the amount of funding being allocated on self-advertisement that would only be available for half the year and suggests more affordable alternatives such as banners, a-frames or a badge instead.

Women's Representative also notes that in instances regarding clothing in clubs, the apparel bought under SSAF are property of the university unless the representatives contribute equally to the purchase which would then make them owners of the item.

Vice-President Postgraduate calls for Jasmine Ricciarelli, Bankstown Campus Representative to speak as the seconder of Item 12.14.

Bankstown Campus Representative is absent from the meeting.

Vice-President Postgraduate calls for Sabrina Young, Vice-President Activities to speak as a member who starred Item 12.14.

Vice-President Activities speaks to Item 12.14, moves to amend the amount allocated to the Vice-President Activities from \$30,000 to \$0 and questions why such a large sum of money is being

allocated towards the NaMMS Graduation ball in which could be put to use for more students elsewhere.

Vice-President Postgraduate calls for Crystal Ram, Vice-President Undergraduate to speak for Right of Reply as the mover on Item 12.14.

Vice-President Undergraduate speaks to Item 12.14, acknowledges the concerns of the council, reiterating that the NaMMS Graduation Ball is not associated with any club and that the inequitable funds allocated to some campuses cannot be spoken for as those positions for representatives are vacant and doing so would be inappropriate.

Vice-President Undergraduate moves to amend the amount allocated to the Vice-President Activities be changed from \$30,000 to \$0 as requested by the Vice-President Activities.
