9. President's Report

Vice-President Undergraduate addresses the attendees of the Student Representative Council Meeting.

"So, moving forward, I will now provide a President's report as that position is now vacant and there's quite a few things I want to. “I want to apologize for not inviting everyone in the SRC to the budget committee meeting. I will be doing that in future. It is a little bit ambiguous, like who goes. So, I know in the session orders it says everyone will go. So that will be done in future, and we are going to be making monthly budget committee meetings just to keep on top of the finances.

So if anything gets directed to the budget committee, having one every quarter is just going to slow the process down. We want the budget committee to be more of a consultation place, so

facilitating that would be better if it was every month, and that might be a week after these general meetings or maybe another time, but that's probably going to be something we can discuss after this.”

One of the major religious festivals in Hinduism, Jainism, and Sikhism, lasting for five days. Celebrations such as Diwali are made more meaningful because they are shared with family and friends. This expenditure will allow for an array of activities and events for throughout the month. This event will help to promote and profile the importance of multiculturalism, mental health and wellbeing of both international and domestic students.

Vice-President Undergraduate: You can amend it.

General Secretary: So, point of order. You are the chair at the moment and because you didn't relinquish beforehand, you won't have speaking rights on it, but Afroze can speak, and we can move forward. So, Afroze can speak as the seconder and then Caitlin will be the person to speak as person that starred it.

Vice-President Undergraduate: So, what we will do is, as chair, I will not be able to speak on this motion. I will give, I waive my rights for obvious reasons, and I will give the time to Afroze.

Vice-President Postgraduate: So, thank you guys. We were assessing that when Crystal was doing this, we had a President by then, but unfortunately, like so I will take this opportunity to give her point of view on this issue as well.

So, in this motion, we are looking to spend on the Diwali activities. I feel like in at our restaurants, university, we have a lot of people from this background that celebrate Diwali, and I feel it is very important that, you know, 700,000 people of the Indian community live in Australia and most of them go to the Western Sydney University as well.

Being at a very good spot, it is very like approachable for these students to get to Western Sydney Westerns University so they opt for our university. So obviously when they offer our university, they feel like they are coming to a place that where they can feel and practice their beliefs easily and I feel that moving. This is nothing in comparison to, you know, them spending their three, four years with us. So please I hope that, you know, it passes.

Vice-President Undergraduate calls for Online Representative, Caitlin Marlor to speak as the member who starred Item 12.6.

Online Representative: Okay, great. So first of all, I would like to say congratulations to such a great idea.

I think supporting Diwali and the broader community is excellent and something that we need to be doing. My main concerns in regards to this motion is that it is quite a lot of money with no actual breakdown of how it is going to be used, what events will be run, or how it is going to be spent and I really think as SRC we sort of need to be raising the standards and seeing more detail in these sort of motions and yeah, honestly like if you guys want to amend it, I would be happy to support it. But yeah, there's just not enough detail for me.

Vice-President Postgraduate: Yeah, so what kind of amendments you are after because I feel that this event will help to promote like a lot of multiculturalism, culturalism at the university. At the same time, it is very important for the mental wellbeing of the students as well, and it is not just restricted to one specific religion.

Everyone will be invited and like the previous that the SRC has gone, everyone will be invited to these. So, like having a look at those aspects and having a look at the population of the Hindus, of the Indians that are present in the Australia. I think \$5,000 is nothing. We should give more if anything.

Vice-President Undergraduate: I'm just going to confirm with Grant and Richard who are in the meeting if we are able to amend the motion to right now, because I'm chair, to amend the movers and seconders.

Student Representative Officer: Realistically, Caitlin's feedback was correct, you should have vacated and moved your own motion, which is what is set out in your meeting agenda. Now, unfortunately for this aspect of the meeting, you've had the seconder share this part of the meeting, so from my perspective, this agenda item is null void. I think you might need to actually defer to the next meeting.

Vice-President Undergraduate: Did you have anything else to add, Grant?

Student Representative Officer: No. Just keeping in mind and this feedback is for all SRC members. Just making sure that you are thoroughly checking your procedures and sessional orders to make sure that you are adhering to your procedures when you are, moving resolutions.

Vice-President Undergraduate calls for General Secretary, Bowen Fucile to speak as a member who has requested to speak on this motion.

General Secretary: I would like to address Grant, sessional order number 47. I'm pretty sure it is 47 or 46, says. If the chair is moving or seconding motion, they may waive their right to speak, but the motion can still be put forward. So since this was put through as the two available chairs, as the mover in the seconder, isn't just speaking rights waived, and then he can actually go to a vote after everyone has had their right to speak on the matter.

Student Representative Officer: Yeah, possibly. I would have to consult the sessional orders, which I don't unfortunately have in front of me. But if that seems procedurally sound to you.

Online Representative: Hi. Sorry, I'm just referring to the sessional orders. Point 50 says that the chair of the meeting needs to be impartial.

I think we can sort of see here that both people that could chair the meeting are moving and seconding the motion. So, they're probably not impartial on the motion considering they've both put substance into this motion. So, yeah, I agree with Grant.
