

Student Representative Member's Reports – Meeting 12

Introduction

I am writing my report for the December meeting relatively early, despite having numerous upcoming meetings, due to my departure on a military training exercise on 29 November 2019. I am however, still able to cover off on my activities since Meeting #11, which have primarily revolved around administration and grievance resolution, as well as SRC Public Relations.

Administration + Public Relations

Since the last SRC meeting, I have become even more active in the area of grievance resolution, debriefing members in person, or in a meeting setting, and ensuring procedural fairness is maintained for a number of incidents currently under investigation by both the SRC and SR+P. Whilst this has been a challenging task, especially considering my inability to comment despite student interest in these issues, I feel that we are making strong progress, and I am hopeful that some of our long standing issues as a council will be addressed by the time of my return upon the conclusion of my first training exercise in late December.

Furthermore, I have also been actively involved in public relations activities relating to the SRC, having appeared in the new SRC video currently being produced by SR+P, as well as writing an editorial for the latest addition of W'SUP, encouraging students to play a greater role in student representation, advocacy and life on our campuses. Finally, I was in attendance at the Student Leadership Night, where I delivered an address to students which not only mapped out the SRC's priorities for 2020, but will hopefully our students to step-up, and help us improve life at Western for all.

Strategic Planning + University Governance

In terms of moving forward our agenda for 2020, and following up on key areas of University Governance, I have a number of meetings with members of the University Executive this coming week. I will be meeting with Michael Burgess, albeit now over Zoom, on Tuesday 26th November to discuss our plans for student life, as well as the streamlining of security assessments, and the current availability of facilities, for students planning events. I am also meeting with the Bankstown CBD Campus Change Committee on Wednesday to follow up on some updates to the internal fit-out plan of Level 04, which both SR+P and I feel will better suit that needs of our Clubs, Societies and Collectives into the future, especially if we are successful of our overhaul of clubs and societies moving forward. Finally, I have a meeting with the Vice Chancellor on Thursday 28th November to discuss a number of crucial issues, including the current status of the proposed SSAF Framework developed by a number of students and staff, myself included, last year, as well as student consultation (and lack there-of) in the wind-up of Western Unlimited. I am hopeful that this will lead to greater student input on the Gyms, Co-Op, and other key aspects of students services.

Academic Integrity

The materials for the Academic Integrity Student Ambassador Program have now been finalised, and I am looking forward to implementing the pilot of the program in the first quarter of 2019. Furthermore, I am flying to Melbourne on 26 November to represent both Western SRC, and the University, at the TEQSA Academic Integrity Workshop, which I feel will be a great opportunity to continue to build upon my understanding of this crucial area for our students.

SSAF

I have also been involved with the ongoing coordination of the National Campaign on SSAF, run by the National Union of Student, having met multiple times to continue to flesh out the nature of the campaign itself. As it develops, it seems increasingly committed to actively campaigning for Universities to ensure that their student advocacy bodies are independent of the institutions themselves, which gives me hope that this campaign could expedite the transition of the SRC into a Student Association.

Furthermore, I also assisted Mandii and Danielle in promoting the issues surrounding the Penrith Community Garden, not only writing to a number of senior members of the university executive, but also starting a petition to raise further awareness amongst the students. I am very proud of Mandii and Danielle's work in this space, and am pleased that due to our collective efforts, it is now moving forward once more.

Vice President – Education (Postgraduate) & NUS Delegate – Daniel Bonatti

Discussion ensued and ideas for 2020 flourished. I hope to continue relations into next year and work alongside them for my collective.

Environmental Representative – Danielle Wolf

Well this has been a pretty chock-full and stressful period. Coming to the end of the year has coincided with all the structuring I've been doing of the Collective coming together, and of course trying to get all my budget requests in by November 30th. Further, due to some mix up with Minutes, I had to spend extra time trying to get that sorted. I've also had meetings and emails regarding the KW Garden, for which a space has finally been approved, and in the location that I was hoping to install the long term project I have planned.

There has also been the SRC training modules to complete, and extensive time planning for CoP25, which is now unfortunately highly unlikely to go ahead, even though it has been moved to Spain following the unrest in Chile.

To pursue action on the garden I also attended the Penrith Provost meeting, which led to the positive outcome noted above. I have had a brief discussion with Brendan from OEC about how to best ensure utilisation of the funding before the end of the year, and am

hoping there might be an opportunity to work with the contractor employed to build and install the framework, etc. I have continued to explore opportunities for networking with external stakeholders and am seeking collaborations with Lyttleton Gardens' Farm-It-Forward initiative.

I have also been working hard on the UN SDSN Youth SDG Students' Program which I am hoping will present the members of the Collective with significant professional development prospects next year. I have further been investigating what other educational opportunities exist with relevant and highly regarded organisations, particularly those which would result in recognised qualifications.

Disabilities Representative – Vicky-Rae Renier-Clark

LGBTIQ+ Advisory Committee with Choice and Connect Division of Autism Spectrum Australia [30th September & 25th November]

I personally believe that the training provided to myself and my peers as part of this committee assists myself and others to understand the complexities of navigating the realm of NDIS as a Queer and Disabled individual. As this is not something that the university offers us training in more broadly as Disability Reps and Officers, I believe that such opportunities are prudent for the advancement of community and understanding of the struggles of Queer and Disabled students when navigating the NDIS and requesting support services.

I was not allocated any tasks as per action items or resolutions for this period by the SRC. I was, however, allocated the task of distributing the Disability Collective handover document

to the Equity Collective Working Group for their perusal in the creation of similar documents for the other equity groups this was sent and received by the Equity Collectives on the 17th of September. I also assisted Kezia with the creation of the Ethics Code in asking her to also include considerations of all areas of accessibility in university campaigns, initiatives and events. This was submitted to the working group via email on 8th November.

The Disability Collective has been steadfastly working on several different campaigns within the university in this space, these include but are not limited to our on-going projects in relation to:

Addressing the complaints of Students with Disability in relation to the Flipped Learning Model [Ongoing]

It has been highlighted by several students, primarily on the Milperra and Liverpool campuses, that the flipped learning model adopted by the university is not compatible with the learning styles of some students with various disabilities who fare better with a face to face physical learning environment compared to an online platform. During these conversations, students outlined feelings of isolation from the university and hesitation with being expected to teach themselves the materials in line with their able-bodied peers. Some with AIP accommodations also noted that these accommodations are not taken into consideration within the online platform which is consequently leading to a high failure rate amongst students with disability. I have raised this as an issue at several meetings of the Academic Planning and Course Approvals Committee as an Undergraduate Representative and look forward to our meeting shortly with Kevin Bell of Digital Futures alongside Academic Senate Representative, Hollie Hammond to discuss the issue of Accessibility across the University's Multimedia Platforms.

Pushing for a more inclusive RNA Policy for all students not just those who are female identifying [Ongoing]

It has been identified again by several students over the last few months that the university needs to adopt a more inclusive voice when dealing with its current RNA policy. Students feel that despite the statistics that were revealed in the Universities Report that Students with Disability are one of the highest minorities with poor reporting rates that the university has not done enough to include those with disability within their advertising and marketing for the taskforce project nor have disabled voices been added to the consultation process regarding the reporting portal as students with varied disabilities may not be able to use the portal to report as it is not supported by such assistive technologies as screen readers.

These sentiments were also largely echoed throughout the male and queer cohorts of students that I managed to have conversations with that also feel that their voices are not being adequately represented by the task force and have asked that our campaign also encompass their voices also to create a more inclusive campaign that goes beyond the realms of those that are female identifying. It was pointed out that male victims also receive

less support by counselling services both in the university and externally when trying to report an incident. We are investigating various options to resolve this currently.

Consultations surrounding accessibility and student engagement in the Vertical Campus Precinct with other global universities such as the University of the West of Scotland (Paisley Campus) [28th – 30th October]

These conversations with members of the UWS Paisley SRC came about over the series of three days during my recent trip to Scotland which formed part of my placement for my Associate's Diploma in Paleoanthropology at UNE whilst I was a presenter at the university. I took the opportunity to meet and discuss with their current SRC members how they tackle the issue of maintaining accessibility and student engagement in the vertical campus model as most of their campuses are too taking the vertical campus approach, however, the accessibility and student engagement within these spaces was much higher than I have personally experienced at Western, For example; with the addition of lifts to the various floors of the campus all stairwells also have a chair lift. All multimedia communications by the university on their digital screens included open captioning and their lectures which I was proud to be a presenter at all included the equivalent of an AUSLAN interpreter. It was explained to me that the interpreters were students that had either undertaken an accredited course in sign language or student volunteers who volunteer their time for academic credit – this is probably an idea to take to the Academy later. I also asked how they tackled the issue of poor mental health outcomes on their campuses as due to the Scottish weather being rather cold and drab more times than not, I believed that there would be a high prevalence of Seasonal Affective Disorder within their student population especially amongst International Students that perhaps came from brighter places. They informed me that they generally have three initiatives that combat such issues:

- Sisterhood Lunches bi-weekly where the ladies all come together over a free lunch prepared together funded by the SRC and have an open mic session where the women can speak openly on any topic with a mutual respect of what gets said in the room stays in the room unless someone discloses wishing to harm themselves or others.
- 2. Barbecues for the boys, under the same premise as the afore mentioned Sisterhood sessions but with men and men's health in mind.
- 3. International Student Welcome Wagon where the SRC comes to Residence with a literal cart filled with things such as branded tea towels and other small homewares to make international students feel at home. They have found this to be a great initiative that really builds comradery and friendships from the genesis of some international students' academic careers with various members of their SRC.

I have also had a few consultation and brainstorming sessions with VPA, Mandii Carr:

Brainstorming Session with VPA, Mandii Carr surrounding arrangements for C3 Congress 2020 [16th November]

I believe that this was a very productive session as Mandii, and I managed to identify a few areas for improvement within the current event program including the inclusion of Menti within some of the sessions to keep students more engaged. I n addition to this, I also supplied Mandii with the Accessibility for Events Checklist that had previously been supplied to the Equity Collective working group for consideration and implementation in events going forward. Mandii informed me that she would also pass the checklist on the CLO, Larissa Baker for consideration in Campus Life events as it was noted that the Disability Collective often gives feedback where events could have possibly been more accessible. I am happy to also forward this document to other groups/departments on request.

Parramatta Town Hall Meeting [24th October]

Alongside other representatives of the Disability Collective, has been ensuring that the university's new builds are fully accessible in concept, execution and design for all people. This ideally includes the digitalization of the campus maps to include not only all accessible facilities but to also demonstrate a route to the proposed destination by the most accessible route on request. This has been an ongoing project that urban Planning Student and Parramatta Disability Collective Officer, Paulin Tan has been working on alongside myself, Disability Services and the Office of Estate and Commercial. We have also had the support of a number of different lecturers within the Urban Planning degree program who have offered us some incredible insight such as the use of certain software such as NearMap which has the capability to access elevations in the university landscape required for accessibility mapping of possible routes around the campus for both wheelchair users and persons with mobility issues. This project was pitched to VC, Barney Glover at the Parramatta Town Hall Meeting on October 24th and has his full support. Consultations are ongoing.
